



In this regard you are also advised to submit the Financial Assurance in the form of Bank Guarantee for the area put on use for Mining and allied activities @ Rs.Two lakhs/hectare for category 'B' mines provided that the minimum amount shall be Rs.Five lakhs as per the provision of Rule 27(1) of MCDR, 2017 at the time of submission of final copies of the document within 15 (fifteen) days from the date of issue of this letter, failing which the document will be disposed without giving any further opportunity.

Draft inspection report cum scrutiny comments in respect of Modification in the approved Mining Plan of Malkapuram Limestone & Dolomite mines of Sri V Satyam over an area of 1.348 ha in Malkapuram Village in Dhone Mandal of Kurnool district of Andhra Pradesh State.

1. Para 1.0.e. The document is submitted with an intention to exploit Dolomite mineral only and stated as there no occurrence of Limestone, whereas as per earlier approved mining plan Limestone occurrence is below Dolomite as indicated in the adjacent lease area which needs to be established with proper exploration, Accordingly para needs to be modify.
2. Para 2.0.b), Land schedule of the lease area to be furnished as ' Govt. waste land' and details of road access to the lease be furnished.
3. Latitude and Longitude of lease boundary pillars authenticated by State Government authority should be furnished. Further compliance of CCOM circular 2/2020 should be commented.
4. Some photograph covering mining operations including pits, waste dumps, haul road etc. should be submitted.

#### Review of Mining plan

5. Annual Return and Monthly Return since inception of Mines should be submitted and copy of the same be enclosed for verification. As no registers were found maintained for verification during field visit, in this regard Production & Dispatch of Ore duly certified by State Government authority should be submitted.
6. During inspection, it is stated that Limestone of 28287 Tonnes of Limestone was dispatched without having any production proposal of Limestone in the earlier approved document, the same be detailed with proper justification.
7. Para 3.4, details of violations pointed out by IBM should be furnished.
8. Para 3.4, Reason for modification needs to be furnished clearly with justification; like Production enhancement than the earlier approved document is noticed, Lease period extension for 50 years as per MMDR Act 1957 amended in 2015.

#### Geology and exploration

9. Para 1.0 a), during inspection it is observed that the lease area is part of Hillock and Valley portion, the same should have been furnished in detailing the para Topography. Further, substantial growth of natural vegetation is observed, the same be detailed in para Vegetation.
10. Contact zone of Shale and Dolomite depicted in Surface Geological plan is incorrect, Shale is found in Section C-C' and D-D' also, in this regard Geological mapping should be done again with few trial pits to establish the same.
11. Reserves and Resources should be re estimated in view of comment at Sl. no.10
12. Recovery of ore is considered as 95%, which needs to be justified.

#### Mining

13. Year wise excavation proposal should be modified in view of comment at Sl no.10.
14. Drilling and Blasting: Sub grade drilling should have been considered for computation of Drilling machine and consumption of explosives.

15. Area put to use for FA should computed in view of comments above.
