Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Yadwad & Kunnal Limestone Mine over an extent of 798.01 Ha. in Belgavi district, Karnataka State.

Sir,

The following provision of the Mineral Conservation and Development Rules, 2017 was found violated in your above mine during the inspection on **16/03/2018** by undersigned in presence of the mine officials Shri Mukesh Kumar Sinha, Mines Manager, Shri Sunil Kumar Sharma, Mining Engineer, Shri Raman Arunachalam, Geologist and other officials of the mines.

11(1)	The mining operations are required to be carried out in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines (IBM).
	In the modified Mining Plan approved by IBM vide letter No. MMP/Mech-02/(KNT)/Goa/2017-18 dated 15.12.2017 under Chapter 3.0-Mine Drainage it was proposed during the year 2017-18 to construct two RR dry retention walls at the bottom of the topsoil stocks and dumps with dimensions of 565m x (1-2m) x 1 m and 360m x (1-2m) x 1 m. Although financial year 2017-18 is nearing completion, no progress has been observed for construction of aforesaid retention walls.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 03. The mining operations can be suspended under rule 11(2) if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
