The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 11/01/2018 by the undersigned along with Shri Kalmata M.K., SMG, IBM Goa in presence of Mr. Subramany, Director and Mr. Gopalkrishna V. Gaonkar.
