The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 25/10/2017 by the undersigned in presence of Shri Runesh Pangam Mines Manager

Rule	Nature of Violation observed
11(1)	 a) In the approved modified mining plan dated 21.02.2017 there was a proposal to drill 23 core boreholes to a total depth of 1080 mtrs in the year 2016-17 and 79 boreholes to a depth of total 4110 mtrs in the year 2017-18, During inspection it was noticed that only three boreholes were completed and in the form I submitted to this office datedonly 10 boreholes were proposed. b) It was propose to handle about 4,96000 tons of waste in the year 2016-17. However only 58744 tonnes is handled. The waste is not handled as per the proposal and Ore to OB handling ratio is not maintained. c) In the year 2016-17 it was proposed to work between the co-ordinates N-1673665 to N1674225 & E-401315 to E-401780 and Rls 120 to 78. During field visit it was observed that working has been not carried out as per the proposal.
26(2)	An yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted for the year 2016-17 so far.
67	A self appraisal note to be submitted by the mines owner/lessee stating extent of implementation of approved minig plan/scheme of mining during the year 2016-17 along with supporting plan & sections ,representative photographs is not submitted to this office so far in hard as well as soft copy.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
