विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Chhelana Bauxite Mine over an area of 12.67 ha located near Village-Chhelana, Tehsil-Kodinar, District-Amreli in Gujarat.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 26.6.2021 AN in the presence of Sh. Manu Mori/ Sh.VK Jain.

<u>RULE NO.</u>	<u>NATURE OF VIOLATION OBSERVED</u>
Rule 11(1)	The mining operations are not carried out as per approved Review of Mining Plan vide letter No 684/(4)(1)/MP-271/2020-21 dated 07/10/2020 for the period of 2020-21 to 2023-24 to the extent indicated below. <u>Exploration</u>-It was proposed to drill 04 number of borehole, each 25m depth as earmarked in plate No.2A & page-12 in present plan period year 2020-21 but no such exploration work done & details reported to this office till date.
26(2)	A yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan for 2020-21 has not been submitted to this office.
Rule 45(5)(b)	The holder of a mining lease shall submit <u>online returns</u> in respect of each mine to the Regional Controller or any other authorized official of the Indian Bureau of Mines in the following manner. (b) a monthly return which shall be submitted before the 10th day of every month in respect of the preceding month in electronic form along with a signed print copy of the same if it is not digitally signed, in the prescribed form. In your case, you have not submitted the online monthly returns from April, 2021 onwards to till date.
Rule 45(5)(c)	The holder of a mining lease shall submit <u>online returns</u> in respect of each mine to the Regional Controller or any other authorized official of the Indian Bureau of Mines in the following manner. © an annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form along with a signed print copy of the same if it is not digitally signed, in the prescribed form. In your case, you have not submitted the online Annual return of 2020-21 to this office till date.

- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- Mining operations can be suspended as per rule 11(2) in case of non compliance of rule 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.
- .00Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
