2. In addition to above, it is to inform you that violation issued by this office dated 08/6/2020 but you have not submitted compliance of VL of rule 11(1), 26(2),33,45(7),55(1)©(i) till date. , hence the VL is still persist.

3. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.

4. Mining operations can be suspended as per rule 11(2) in case of non compliance of rule 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.

5. Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.

6. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
