विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Januda Shantipura Limestone Mine over an area of 41.0 ha located near Village-Januda & Shantipura, Tehsil-Maliahatina, District-Junagarh in Gujarat.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 20.7.2021 in the presence of Sh. Sh. Devayut Vala, Lessee rep.

<u>RULE NO.</u>	<u>NATURE OF VIOLATION OBSERVED</u>
11(1)	The mining operations are not carried out as per approved Review of Mining Plan vide letter No 684(4)(1)/MP-24/2019-20/MDRD,GNR Dated the 04.10.2019 for the period of 2019-20 to 2022-23 to the extent indicated below. <i>Plantation-</i> It was proposed for 500 No of plantation, 1352m fencing for the year 2020-21 as earmarked ground but against proposal, you have not done fencing /plantation & reported to this office till date. Further mining operation were not carried out as proposed.
26(2)	A yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan for 2019-20 has not been submitted cumulative to this office.
Rule 33	The owner, agent, mining engineer or manager of mine shall submit the digital copy along with a print copy of the Surface Geological plan & section on or before the 30th June of every year. In your case, you have not submitted the aforesaid updated plan & section maintained under rule 32 of MCDR, 2017 to this office till date.
45(7)	While scrutiny of annual return 2020-21, following discrepancies observed, which are furnished as below. Part-I, Sr No.12, land used details mentioned as Abandoned & current OC working are not given correctly, Part-VII (Cost of Production-mining cost mentioned zero, beneficiation cost mentioned 80Rs/T which are not correct, therefore Ex Mine price needs to be corrected & furnished as per above scrutiny. Mineral Stock needs to reconcile & corrected.

2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
3. Mining operations can be suspended as per rule 11(2) in case of non-compliance of rule 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.
4. Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
5. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
