Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Chikkashellikere Limestone Mine, Area – 8.09Ha,(M.L.No.2262), situated in Bagalkot-District of Karnataka State.

#### Sir.

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 07/03/2018 by the undersigned and communicated to you vide this office Regd A/D Letter no. even, dtd.22/3/2018 giving you period of 45(forty five) days time for rectification of the same.

Rule	Nature of Violation observed
11(2) & 27(2)	The information contained in the mining Plan is non-complaint under these rule. As a financial assurance of an amount equal to the difference between the financial assurance due as on the date of notification of MCDR,2017 and the financial assurance already furnished,shall be furnished to the authorized officer within a period of ninety days from the date of notification of these rule.  However, the same has not been furnished to the competent authority and such the provisions of rule 11(2) for suspension of mining operations can be invoked.
26(2)	An yearly report on progressive Mine closure Plan before 1 <sup>st</sup> July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive Mine closure plan has not been submitted for the year 2016-17.

02. The reply furnished by you vides letters nil dated 7/5/2018 and 6/6/2018 was duly considered and found that only rule 26(2) of MCDR 2017 has been complied and action taken for compliance of other Rules are not found to be satisfactory.

- 03. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 04. You are therefore, directed to show cause within period of **thirty** (30) days as why you should not be prosecuted for the above offence and/or why mining operations shall not be suspended as per provision of rule 11(2) of MCDR, 2017.
- 05. Please none that no further notice will be given to you in this regards.
