- 02. You are advised to attend these deficiencies as per the annexure and resubmit the document, complete in all respects, in three bound copies along with soft copy in the form of CD (4Nos.). In this regard, you are directed to submit the Financial Assurance in the form of Bank Guarantee for the area put on use for Mining and allied activities @ Rs.Two lakhs/hectare for category 'B' mines provided that the minimum amount shall be Rs.Five lakhs as per the provision of Rule 27(1) of MCDR, 2017 at the time of submission of final copies of the document within 15 (fifteen) days from the date of issue of this letter, failing which the document will be disposed without giving any further opportunity.
- 03. The para-wise clarification & the manner in which the deficiencies are attended should be given while forwarding modified document.

Inspection report cum Scrutiny comments on examination of Review of Mining Plan in respect of Malkapuram Limestone mine of Shri I Sreeramulu over an extent of 2.24 Ha. located in Malkapuram Village, Dhone- Mandal, Kurnool District. of Andhra Pradesh State submitted under Rule 17(2) of MCR, 2016.

Text:

- 1. In cover Page, the rule under which document submitted should be be furnished as 17(2) of MCR 2016
- 2. The document submitted as Review of Mining Plan, the details of the same be furnished in the "Certificate from QP"
- 3. Status of extension of lease period as per Section 8A of MMDR Act 1957 may be furnished, if any.
- 4. Co-ordinates of lease boundary pillars authenticated by State government should be furnished
- 5. Statutory clearance like EC, CFO, CFE, surface right area held by the lessee should be furnished in Introduction chapter.

Review of Scheme of Mining

- 6. Review should be carried out for years 2009-10 to 2013-14 (Earlier Plan period) and subsequent period 2014-15 to 2020-21.
- 7. Annual returns and Monthly returns for the review period for both limestone and Dolomite should be submitted (from 2011-12 through online) and copy of the same be attached.
- 8. Para 3.1, details of all earlier approved mining plan, scheme of mining, review of mining plan etc. be submitted in tabular form.
- 9. Status of violations/ show cause notice issued by IBM for the review period from 2009-10 onwards should be furnished.

Geology & Exploration:

- 10. Para 1.0.b) Regional Geology should have been furnished in detail and Local Geology should correlate with the same.
- 11. Description of litho units be furnished as per actual field condition. Serpentine, tuffaceous Limestone, Dolomite. Photographs of the litho units exposed in the benches be furnished for clarity.
- 12. Justification of UNFC codes should be furnished as per MEMC Rules 2015.
- 13. Feasibility report as per guidelines of MEMC Rules 2015 should be submitted.

Mining:

- 14. The details of year wise tentative excavation should be furnished as per the prescribed format only.
- 15. Procurement of explosives to carryout blasting to be detailed with enclosing the copy of a license obtained from Chief Controller of Explosives.

Conceptual Plan

16. Conceptual plan is not prepared as per the guidelines, UPL considered, life of the mine, reclamation and rehabilitation measures, land use pattern, plantation details etc.at the end of plan period/ lease period are not detailed. The above details be furnished in this para.

Progressive mine closure plan

- 17. Reclamation & rehabilitation measures, afforestation with respect to land use as well as protective measures for safe and scientific mining be detailed as lease will be expiring on 16.05.2025.
- 18. Area considered for Financial assurance is on lower side as most of the lease area has been utilized for mining and allied activities, which needs to be modified.

Plans and sections:

- 19. All the plans and sections should be submitted as per the lease sketch authenticated by State Government.
- 20. Surface Geological Plan: Mineralised and Non mineralized area should be marked distinctly as per the exploration carried out so far and Pit developed.
- 21. Key plan should be submitted on Survey of India top sheet indicating all the features as per rule 32(5) of MCDR, 2017.
- 22. Surface Plan: Standard color code should be used to indicate benches, pit bottom, road, ramp etc for easy reference.
- 23. Surface plan submitted is not matching with actual field condition.
- 24. Dumps on western side of the lease area, have not been depicted.
- 25. Geological section: Lithologs depicted is incorrect which does not show actual field condition. The succession of litho units observed is top soil, LIMESTONE, inert material, Dolomite, alternative layer of serpentine and limestone/ Dolomite and Limestone. Needs to be modified and submitted.
- 26. Year wise proposals shall be submitted in .kml or.shp files in the form of soft copies.
- 27. The land use data to be submitted in digital form (Geospatial data). The land use patterns, feature type and file type required are broadly classified and given below:
