Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017(MCDR,2017) in respect of Muktyala Limestone Mine of M/s The KCP Limited over an extent of 368.35 ha situated in Muktyala Village,Jaggayyapeta Mandal,Krishna District,Andhra Pradesh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 14.07.2018 by Sri. A V Ramesh Kumar, Assistant Mining Geologist of this office accompanied by Sri.B.Anil Kumar,Sr.DGM(Mines):

Rule No.	Nature of Violation
26(2)	The yearly report for the year 2017-18 setting forth the extent of protective and rehabilitation work as envisaged in the approved document has not been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad.
47	The holder of a mining lease or the holder of a prospecting licence or prospecting license cum mining lease shall send intimation in Form I of the Schedule to the authorised officer, as the case may be, within fifteen days after the commencement of any of the following operations. However, you have carried out 66 no.s of Core boreholes during 2017-18 and not submitted Form-I as per the statute.

02. In this connection, it is brought to your notice that the above said violation constitutes an offence punishable under Rule-62 of MCDR, 2017.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45(forty five) days from the date of issue of this letter.
