Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017(MCDR,2017) in respect of Vishnupuram Limestone Mine of M/s The India Cements Ltd. over an extent of 323.12 ha situated in Wadapalli Village, Damarcherla Mandal, Nalgonda, District, Telangana State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 13.7.2018 by Sri. M.Pratap Reddy, Assistant Mining Geologist of this office accompanied by Sri.P.Bheem Raj, Mines Manager:

Rule No.	Nature of Violation
55(1)(c)	Every holder of a mining lease shall employ, in case of fully mechanized category A mines, a whole time Mining Engineer and a Geologist having minimum of five years of professional experience of working in a supervisory capacity in the field of mining. However, a whole time Geologist has not been employed so far as per the provisions of the Rule.
26(2)	The yearly report for the year 2017-18 setting forth the extent of protective and rehabilitation work as envisaged in the approved document has not been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad.

02. In this connection, it is brought to your notice that the above said violation constitutes an offence punishable under Rule-62 of MCDR, 2017.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45(forty five) days from the date of issue of this letter.
