**Sub:** Violation of provisions of Mineral Conservation and Development Rules- 2017 (MCDR-2017) in respect of your Brahmeswara Iron ore and Steatite mine over an extent of 33.01 Ha in Sy.no. 865 of Veldurthy Village & Mandal, Kurnool Dist, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules 2017, was found violated in your above mine during the inspection of the mine on 22.6.2018 by Sri M.Pratap Reddy Assistant Mining Geologist of this office and accompanied by your representative Sri L.Srinivas Reddy:

Rule No	Nature of Violations observed
11(1)	Mining operations are not carried out in accordance with the proposals given in approved Scheme of Mining vide letter no. AP/KNL/MP/Lst-86/HYD dated 30.10.2015 to the extent indicated below: i) It was proposed in Para 1-I and plate-IV to drill total 7 boreholes with a total meter age during 2017-18. It was observed during the inspection that proposed boreholes are not yet drilled to convert the resources into reserves.
26(2)	The yearly report for the year 2017-18 setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved scheme of Mining has not been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad.
24(1)	The holder of ML shall submit of Final mine closure plan to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad for approval prior to the closure of the mine since the mining lease is expiring on 31.3.2020.

02. In this connection, it is brought to your notice that the above violations constitute an Offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
