Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Sulikeri Limetone and Dolomite Mine, Area-10.60Ha, (M.L.No.2391), Smt V.S. Raikar situated in Lokapur Village, Mudhol Taluka, Bagalkot- District of Karnataka State.

Sir.

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 10/03/2018 by the undersigned in presence of Mr. Vijay S.Raikar, Agent, Mr. Shyed Anwar Pasha, Mines Manager and Mining Engineer.

Rule	Nature of Violation observed
11(1)	Mining operations have not been carried out in accordance with the Scheme of Mining approved vide MSH/OTF-MECH-41(KNT)/GOA//2013-14 dated 26/08/2012.  As per the aforesaid approved Scheme of Mining eighteen numbers (18 nos.) of DTH boreholes were proposed to establish the entire reserves and resources G1 categary  Whereas, It was observed during the inspection that only nine numbers(9 nos.) of Core boreholes were undertaken during the approved Scheme of Mining.
11(1) & 26(2)	An yearly report on progressive Mine closure Plan before 1 <sup>st</sup> July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive Mine closure plan has not been submitted for the year 2016-17.
11(2)&27(2)	A financial assurance of an amount equal to the difference between the financial

assurance due as on the date of notification of these rules and the financial assurance already furnished, shall be furnished to the authorized officer within a period of ninety days from the date of notification of MCDR,2017. Thus the provisions of rule 11(2) can be invoked for non-compliance of MCDR rules.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
