Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Nagnapur Limestone Mine, extent over an area of 8.10Ha,(M.L.No.001), M/s Nandi Mining Company situated in Nagnapur Village, Mudhol Taluka,Bagalkot- District of Karnataka State.

## Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 07/03/2018 by the undersigned in presence of Mr. R.M.Jumnal, Company Managing Partener.

Rule	Nature of Violation observed
55(1)	For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules: "Every holder of a mining lease shall employ, in case of category 'A' mines, a full time mining engineer and a full time Geologist".  However during the inspection it was observed that a full time Mining Engineer and Geologist has not been employed under this rule.
45(5)	The holder of a mining lease shall submit online returns in respect of each mine to Regional Controller or any other otherised official of the Indian Bureau of Mines in the following manner, namely:-  (c) An annual return which shall be submitted before 1 <sup>st</sup> day of July each year for the preceding financial year in the electronic form.  However, the Annual Returns for the Faniancial Year 1 <sup>st</sup> April 2016 to 31 <sup>st</sup> March 2017; was not submitted from your mine.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
