विषय Sub: Violation in respect of provisions of Rule 11(1),11(4),26(2),28(2),33 & 45(5)(7) of Mineral Conservation & Development Rules, 2017 in respect of your Khakharda Bauxite Mine, Mining Lease over an area of 34.8 ha located near Village: Khakharda Tehsil: Kalyanpur, District-Devbhumi Dwarka Gujarat State.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 11.9.2021(AN) in the presence of Shri Hitesh Parmar, lessee rep.

<u>RULE NO.</u>	<u>NATURE OF VIOLATION OBSERVED</u>
11(1)	The mining operations were not being carried out as proposed in approved Review of mining Plan vide 682(23) MS(357)/2006-MCCN (M) UDP Dated 13/12/2016 for 2017-18 to 2021-22. <i>Exploitation-It was proposed to work & excavation of production of 100825T for the year 2018-19 but you have done the production of 136874.13T which is 36049.13T excess against proposed quantity.</i>
11(4)	The holder of a mining lease shall submit the mining plan to the competent authority for review at least one hundred and eighty days before the expiry of five years period for which it was approved on the last occasion, for mining operations for a period of five subsequent years. In your case, present Review of Mining Plan is valid up to 31.3.2022.
Rule 26(2)	A yearly report before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan for 2020-21 has not been submitted to this office.
Rule 28(1)	The holder of a mining lease shall send to the authorized officer, as the case may be, and the State Government a notice in Form-E, when the mining & mineral processing operation in the mine or part thereof are dis-continued for a period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such temporary discontinuance. In your case, such discontinuance notice is not submitted to IBM Gandhinagar office so far, whereas mine workings discontinued more than 90 days.
Rule 33	The owner, agent, mining engineer or manager of mine shall submit the digital copy along with a print copy of the Surface Geological plan & section on or before the 30th June of every year. <i>In your case, you have not submitted the aforesaid updated plan & section for the year 2020-21 maintained under rule 32 of MCDR, 2017 to this office till date.</i>
Rule 45(5)(7)	While scrutiny of annual return 2020-21, following discrepancies observed, which are furnished as below- Part-VI-Production, dispatch & stock- cost of production given as 420Rs/T whereas Ex Mine Price reported as 350Rs/T which is less than cost of production and not correct. Details of HEMM, Part-II-Capital structure and Part-III consumption of material is left blank.

- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- Mining operations can be suspended as per rule 11(2) in case of non-compliance of rule 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining.
- Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
