महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 10.9.2021 AN in the presence of Sh. Sh. Jagat Mama Joshi, Lessee rep.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the approved mining plan, modified or reviewed by the Indian Bureau of Mines, whereas it is found that
	<u>you have carried out mining operation without approved mining Plan/Review of Mining Plan etc as follows.</u> Exploitation-It was observed that lessee has been carried out mineral production (ROM) of 9050T for the year 2019-20 without valid Review of Mining Plan as reported in Annual return submitted to this office.
26(2)	A yearly report before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan for 2020-21 has not been submitted cumulative to this office.
28(1)	The holder of a mining lease shall send to the authorized officer, as the case may be, and the State Government a notice in Form-E, when the mining & mineral processing operation in the mine or part thereof are dis-continued for a period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such temporary discontinuance. In your case, you have not submitted discontinuance notice to IBM Gandhinagar office so far.

- 2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 3. Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
- 4. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
