

Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Chorbedi-1 विषय Sub:

Limestone Mine over an area of 254.89 ha located near Village-Chorbedi, Tehsil-Lalpur, District-Jamnagar

in Gujarat.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 07.9.2021 FN in the presence of Sh. Sh. Anil Kr Nigam, Lessee rep.

RULE NO.	NATURE OF VIOLATION OBSERVED
33	The owner, agent, mining engineer or manager of mine shall submit the digital copy along with a print copy of the Surface Geological plan & section on or before the 30th June of every year. In your case, you have not submitted the effected plan & section maintained under rule 22 of MCDP, 2017 to this office till date.
45(7)	the aforesaid updated plan & section maintained under rule 32 of MCDR, 2017 to this office till date.  While scrutiny of annual return 2020-21, following discrepancies observed, which are furnished as below. Part-I, Sr No.12, land used details mentioned for the year as current OC working, reclaimed & rehabilitated, infrastructure-PMCP are not given correctly/matching as per KML etc, Part-VII (Cost of Production-200.17 Rs/T whereas Ex Mine reported 197.14 Rs/T which is less than cost of production needs to clarified & submitted. OB reported as 50T whereas during inspection same was shown as topsoil, needs to corrected. HEMM-Electric truck reported but actual workings is diesel operated.

- 2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 3. Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
- 4. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
