विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Gop-1 Limestone Mine over an area of 218.53 ha located near Village-Gop, Tehsil-Jam jodhpur, District-Jamnagar in Gujarat.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 05.9.2021 in the presence of Sh. Sh. Anil Nigam, Lessee rep.

<u>RULE NO.</u>	<u>NATURE OF VIOLATION OBSERVED</u>
11(4)	The holder of a mining lease shall submit the mining plan to the competent authority for review at least one hundred and eighty days before the expiry of five years period for which it was approved on the last occasion, for mining operations for a period of five subsequent years.
26(2)	A yearly report before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan for 2019-20 has not been submitted cumulative to this office.
45(7)	While scrutiny of annual return 2020-21, following discrepancies observed, which are furnished as below. Part-I, Sr No.12, land used details mentioned for the year as current OC working-96.88Ha, reclaimed & rehabilitated-4.65Ha, infrastructure-3.167Ha, PMCP-0.78Ha are not given correctly, Part-VII (Cost of Production-197.37 Rs./T whereas Ex Mine reported 192.6 Rs/T which is less than cost of production needs to clarified & submitted. OB reported as 30T whereas during inspection same was shown as topsoil, needs to corrected.

2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
3. Mining operations can be suspended as per rule 11(2) in case of non-compliance of rule 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.
4. Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
5. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
