The same has been forwarded to you and your Qualified Person on respective e.mail ids i.e.,saibalajiminerals3@gmail.com and shridharmbhatgoa@gmail.com.

- 02. You are advised to attend the deficiencies as per the annexure and resubmit the document, complete in all respects, in three bound copies along with soft copy in the form of CD (4Nos.). In this regard, you are directed to submit the Financial Assurance in the form of Bank Guarantee for the area put on use for Mining and allied activities @ Rs.Five lakhs/hectare for category 'A' mines provided that the minimum amount shall be Rs.Ten lakhs as per the provision of Rule 27(1) of MCDR, 2017 at the time of submission of final copies of the document within 15 (fifteen) days from the date of issue of this letter, failing which the document will be disposed without giving any further opportunity.
- 03. The para-wise clarification & the manner in which the deficiencies are attended should be given while forwarding modified document.

Scrutiny comments on examination of Review of Mining Plan of Obulapuram Iron Ore Mine M/s. Sai Balaji Minerals over an area of 4.046 Ha in Obulapuram Village, D- Hirehal Mandal, Anantapur District, Andhra Pradesh submitted under Rule 17 (2) of MCR 2016.

#### General

- Deed of admission-cum-retirement submitted is not signed by the retiring partner and not registered under Register of Firms.
- The lease area submitted in the .kml file is 3.85 Ha which is different from the original area as per the lease deed. Clarify it.
- 3. Status of implementation of CCOM Circular no. 2/2010 to be submitted.
- DGPS surveyed lease sketch authenticated by the Director of Mines and Geology shall be submitted.
- Clarification is sought in the form of affidavit clearly stating that no issues related to illegal mining, royalty payment, safety & environment of general public, public interest litigation and court case.
- Review of Mining Plan document is not submitted in the excel format as mentioned in the CCOM Circular 1/2021 dated 08.09.2021.
- 7. During inspection it was found that two lease boundary pillars (A & K) are not installed.
- 8. In the annual returns (2021-22) data for stock of 18785 tonnes of ROM, 7656 tonnes of lump ore and 776 tonnes of fine ore is submitted, whereas during inspection it was noticed that no such stock is present within the mining lease.
- 9. The document shall be submitted as per the format mentioned in the FAQ on format of Mining Plans issued vide CCOM Circular 1/2021 dated 08.09.2021.
- The final document shall adhere the conditions stipulated in CCOM circular No. 01/2021dated 07.06.2021& FAQ on format of Mining Plans issued vide CCOM Circular 1/2021 dated 08.09.2021.
- 11. Color photographs should be enclosed as annexure for easy reference pertaining to boundary pillars, working pit, dump, afforestation, core logs, ground control points etc.
- 12. It is proposed to carry out the excavation and loading with machineries. Hence copy to HEMM permission under MMR 1961 for use of machinery shall be submitted.
- 13. Digital aerial images of the mining lease area as per Rule 34A (3) of MCDR Amendment Rules 2021, shall be submitted.
