The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by Shri R.Majumder, RMG on 1.4.2021 in the presence of Shri Rajesh Ker & Shri D.Gaur -

NATURE OF VIOLATION OBSERVED
The mining operations were not being carried out as proposed in approved Review of mining Plan vide 684(4)(1)/MP-
266-GNR Dated 29.5.2020. Excavation-In page 61 of the approved proposal, 100 saplings was proposed to be planted and 320 m fencing was to be carried out. No
such work has been carried out. [2020-2] A yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted to this office.
In your case, you have not submitted the previous year (2020-21) online annual return and monthly returns till date.
A full time Mining Engineer and Geologist have not been employed for the purpose of carrying out mining operations in accordance with these rules.

2.On examination of office record, it is found that you have not submitted any reply of violation to this office till date and it is found that violation of provision of rules 11(1),26(2),45(5)© & 55(1)© is still persists

3.In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62(1) & 62(2) of MCDR 2017 (as amended up to date) and respective schedule to these rules / including violated rules.

4. Mining operations can be suspended as per rule 11(2) in case of non-compliance of rule 11(1), further mining operations can be suspended as per provision of Rule 45(7), the Regional Controller of Mines may take appropriate action including order of suspension of all mining operations and dispatches on non-compliance of various provisions of Rules.

5. You are also liable to pay an amount of Rs. 10000/-per day for such days as per Schedule-II, read with Rule 45(7A) in case of noncompliance of various provisions of Rules.

6. You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted and / or penalty/fine etc. to be imposed and /or why the mining operation should not be suspended under relevant statutory provisions and/or why not any other appropriate action can be initiated in accordance with rules and/or any competent orders/directives.

7. Please note that no further notice will be given to you in this regard.
