विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Vadekhan Limestone Mine over an area of 4.0 ha located near Village-Vadekhan, Tehsil-Upleta, District-Rajkot in Gujarat.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 30.6.2021 AN in the presence of Sh. Hardas G Bhimbha, lessee

<u>RULE NO.</u>	<u>NATURE OF VIOLATION OBSERVED</u>
11(1)	The mining operations were not being carried out as proposed in approved of mining Plan vide 684(4) (1) MP-210)/2019-खानिखस)3/(GNR Dated 08.4.2019 :-<i>Exploitation</i>-It was proposed ROM production of 1, 44,509T and 90859T for the year 2018-19 and 2019-20 but you have done the production of 1,52,000T and 219000T respectively which is 7491T and 128141T excess against proposed quantity.
26(2)	<i>A yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved PMCP for 2019-20,2020-21 has not been submitted to this office till date.</i>
Rule 28(1)	The holder of a mining lease shall send to the authorized officer, as the case may be, and the State Government a notice in Form-E, when the mining & mineral processing operation in the mine or part thereof are dis-continued for a period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such temporary discontinuance. In your case, discontinuance notice is not submitted to IBM Gandhinagar office so far.
Rule 33	The owner, agent, mining engineer or manager of mine shall submit the digital copy along with a print copy of the Surface Geological plan & section on or before the 30th June of every year. In your case, you have not submitted the aforesaid updated plan & section maintained under rule 32 of MCDR, 2017 to this office till date.
45(5)©	The holder of a mining lease shall submit <u>online returns</u> in respect of each mine to the Regional Controller or any other authorized official of the Indian Bureau of Mines in the following manner. © an annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form along with a signed print copy of the same if it is not digitally signed, in the prescribed form. In your case, you have not submitted the online Annual return of 2020-21 to this office till date.

- In addition to above, it is to inform you that violation issued by this office dated 04/6/2020 but you have not submitted compliance of VL of rule 11(1), 26(2),33,45(7),55(1)©(i) till date & VL still persist .
- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- Mining operations can be suspended as per rule 11(2) in case of non compliance of rule 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.
- Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
