28(1)	The holder of a mining lease shall send to the authorized officer, as the case may be, and the State Government a
	notice in Form-E, when the mining & mineral processing operation in the mine or part thereof are dis-continued for a
	period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such temporary
	discontinuance. In your case, you have not submitted discontinuance notice to IBM Gandhinagar office so far.
33	The owner, agent, mining engineer or manager of mine shall submit the digital copy along with a print copy of the
	Surface Geological plan & section on or before the 30th June of every year. In your case, you have not submitted the
	aforesaid updated plan & section maintained under rule 32 of MCDR, 2017 to this office till date.
45(7)	While scrutiny of annual return 2020-21, following discrepancies observed, which are furnished as below. You have
	submitted the NIL/Incomplete information in Part-I to Part-IV which is not correct. It needs correction.

- On examination of office record, it is found that you have submitted reply of violation dated 25/8/21 received in this office on 01.9.2021 but not found satisfactory and it is found that violation of provision of rules 11(1),28(1),33,45(7) is still persists
- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62
- Mining operations can be suspended as per rule 11(2) in case of non-compliance of rule 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining.
- Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 30 days from date of issue of this letter.
- You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted and / or why the mining operation should not be suspended under relevant statutory provisions and/or why not any other appropriate action can be initiated in accordance with rules and/or any competent orders/directives.
- Please note that no further notice will be given to you in this regard.
