विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Aniyari Limestone Mine over an area 23.88 ha located near Village- Aniyari, Tehsil- Ranavav, District- Porbandar in Gujarat.

महोदय Sir, The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 14.07.2021 in the presence of Shri Bharat Bhai /technical person rep.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved ...vide letter No 684(4)(1) MP-268 2020-21, Dated 13.8.2020, for the period 2020-21 to 2024-25 In Para 8 (page 51), it was proposed that in year 2020-21, plantation of 500 no plants but no plantation has been carried out in the year 2020-21 against the proposal of 500 saplings as per proposal given in the approved Review of Mining Plan
26(2)	A yearly report before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan for 2020-21 has not been submitted to this office
33	The owner, agent, mining engineer or manager of mine shall submit the digital copy along with a print copy of the Surface Geological plan & section on or before the 30th June of every year. In your case, you have not submitted the aforesaid updated plan & section maintained under rule 32 of MCDR, 2017 to this office till date.
45(7)	In your case, while scrutiny of annual return for the financial year 2020-21 following discrepancies are observed Further previous year annual return is also not submitted. (1) Part-I, Sr.No 8 & 9, Name of Geologist and mining engineer have not mentioned. (2) Part-I, Sr.No 12 - Area under Land use details are not correct. Needs correction. (3) Part II, Sr.No 1, Name of Mining Engineer and geologist has been left blank. (4) Part-III, Sr.No 5, Maintenance cost has not been mentioned. (5) Part-IV, Sr.No.2 & Part - IV - Computation of Ex-mine price Cost of Production of chemical grade lime stone and cement grade limestone may be mentioned correctly.
55(1)(c)	For the purpose of carrying out reconnaissance, prospecting or operations in accordance in with the rules- Every holder of a mining lease shall employ, in case of (i) category "A" mines, a whole-time mining engineer a geologist. In your case, you have not employed a whole-time geologist and a mining engineer.

- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- Mining operations can be suspended as per rule 11(2) in case of non-compliance of rule 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.
- To Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
