The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 9.7.2021 in the presence of Shri D.K.Singh /technical person rep.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	As per the approved Review of Mining Plan vide dated 16.10.2019 for the period 2019-20 to 2023-24, in the page 27 it is proposed to drill 28 no boreholes in the year 2020-21 but the same has not been drilled till date.
45(7	 (2) Part I. Sr No 9 – Name of geologist has not been mentioned. Violation has been pointed out in this regard. (3) Part-II. Sr No 1- No of whole time geologist has not mentioned.
55(1)(3)	i) A whole time Geologist has not been appointed to carry out the duties as required under these rules.

- 2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 3. Mining operations can be suspended as per rule 11(2) in case of non-compliance of rule 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.
- 4. To Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.

5. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
