The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in the above mine during the inspection on 28/07/2022 by the undersigned in presence of the mine officials Shri Y. Saidulu, Manager (Mines) and Shri M. Dheivendiran, Geologist.

Rule 45 (7)	Annual Return F.Y. 2021-22: Part IV; Consumption of Explosive: 3. Overburden removed (in Tonne): The mentioned figure under this para is incorrect as the removed quantity 9338.00 metric tonnes is not overburden. Factually it is topsoil generated during F.Y. 2021-22.  Part – VII; Cost of Production: For computation of cost of production, cost of transportation from mining lease up to the captive plant should not be added.
	Monthly Returns: April 2022 to June 2022  Part II (Production, Despatches And Stocks) (Limestone); 3(ii) Grade-wise Production, Dispatches, Stocks and Ex-mine prises: For computation of cost of the Ex-mine price, cost of transportation from mining lease up to the captive plant should not be added.

- 02. In this connection, it is brought to your notice that the violation of aforesaid rule constitutes an offence, punishable under Rule 62(1) of MCDR, 2017 as well as Fine may be imposed as specified under Schedule-II of rule 45(7A) of MCDR, 2017 Amended up to 3rd November 2021.
- 03. The mining operations and dispatches can be suspended under rule 45(7), if compliance of rule 45(7) is not found satisfactory.
- 04. You are therefore directed to show cause within a period of 30 (Thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.
- 05. Please note that no further notice will be give to you in this regard.
