Sub: Violation of provisions of MCDR, 2017 in respect of Robo Manganese ore Mine over an area of 4.747 ha in D.Gadabavalasa Village, Vizianagaram district, Andhra Pradesh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 14.08.2021 by Sri A V Ramesh Kumar, Assistant Mining Geologist of this office accompanied by Sri Sri K. Krishna Rao, Mines Manager.

Rule No-	Nature of violation
11 (1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section(2) of section 5. “It was proposed to carry out 04 No.s. of boreholes in the plan period during the year 2020-21. However during inspection, it was observed that no such drilling of boreholes was carried out”.

02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-62 of MCDR, 2017. Further, inability to comply the provision of Rule 11(1) is liable for suspension of mining operations under Rule 11(2) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
