The following provision of Mineral Conservation & Development Rules, 1988 were found violated in your above mine during the inspection on 12/05/2016 (A/N) by the undersigned in presence of the Shivanand L.Udapudi, Lessee.

Rule	Nature of Violation observed
13(1)	The mining operation in the lease area are not carried out as per approved mining plan and following deviations are observed during inspection. a) In the chapter 9.0 under afforestation programme and on the plate No-6, there was a proposal to plant 125 saplings during the scheme period along southern part of leasea long the safety zone. During the site inspection it was observed that the plantation was not made as per the proposals given in the approved scheme of mining. b) In northern part of the lease area working has been carriedout in the 7.5m safety zone. c) Some portion of the area has been backfilled in the southern part of the lease area where there is no such proposal in the approved scheme of mining.
12(3)	The Scheme of Mining for next five year period has not been submitted for approval at least one hundred and twenty days before expiry of five year period, for which it was approved on 29/11/11 for the period 2011-12 to 2015-16.
23(E) 2	An yearly report on PMCP before 1 _{st} July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted for the year 2014-15 and 2015-16 so far.
63	A self appraisal note to be submitted by the mines owner/lessee stating extent of implementation of approved minig plan/scheme of mining during the year 2014-15 & 2015-16 along with supporting plan & sections ,representative photographs is not submitted to this office so far in hard as well as soft copy.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988.

03. The mining operations can be suspended under rule 13(2), if compliance of rule 13(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
