The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above said mine during inspection on 15.04.2015 by the undersigned, accompanied by Mr. Rajesh Kumar Mahanta, Mines Manager & Mr. Harendra Narayan Das, Mining Engineer of your mine.

	From Monthly return of April'2014, It is evident that 56731 Tonnes of ROM ore has been
45(7)	processed. Whereas total production of different grades of processed iron ore reported was
	76455 Tonnes, which was more than the quantity of ROM processed by 19724 Tonnes.
	The above discrepancy is construed as misrepresentation and suppression of information as
	per Rule 45(7) of the Mineral Conservation and Development (Amendment) Rules' 2011.
	The exploration in the year 2014-15 reportedly carried out by drilling 20 Bore Holes (400m).
47	However, intimation in Form-J as required to be given to RCOM within 15 days after the
	commencement of boreholes was not given.
	A record in Form-K of all boreholes exceeding 10m in depth and samples of the strata passed
48	through required to be retained are not observed being kept/maintained during inspection in
	respect of boreholes reported drilled.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.

Further, furnishing incomplete or wrong or false information in the returns submitted under Rule 45(5) may lead to suspension of all mining operations in the mine and prosecution of the owner, agent, mining engineer or manager of mine as well as recommendation for termination of mining lease according to provisions of Rule 45(7) of the Mineral Conservation and Development (Amendment) Rules'2011.

03. You are advised to rectify the above violations immediately and intimate the position to this office within **45** (forty-five) days from the date of issue of this letter.
