Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Lanjiberna Limestone & dolomite mine over an area of 873.057 hectare in Sundargarh district of Odisha

The following provision of Mineral Conservation and Development Rules, 2017 was found violated in your Sir. above said mine during inspection on 23.07.2019 by the undersigned along with Shri Jitendriya Pradhan, Assistant Mining Engineer in presence of your mine official Shri Subrat Mishra, Mines Manager.

02 In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operation can be suspended under Rule 11(2), if compliance of Rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (fortyfive) days from the date of issue of this letter.
