Sub : Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Naganapur Limestone & Dolomite Mine (ML No.2609) over an extent of 4.86Ha, situated in Village – Naganapur, Taluka- Mudhol, District-Bagalkot of Karnataka State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 12/07/2018 by the undersigned in presence of Shri A.B Anagal, Mine Owner.

Rule	Nature of Violation observed
11(1) & 26(2)	An yearly report on progressive Mine closure Plan before 1 <sup>st</sup> July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive Mine closure plan has not been submitted for the year 2016-17.
55(1) ( c ) ( i )	For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules: "Every holder of a mining lease shall employ, in case of category 'A' mines, a full time mining engineer and a full time Geologist". However during the inspection it was observed that a full time Mining Engineer has not been employed under this rule.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of these rules is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
