Violation of provisions of Mineral Conservation & Development Rules, 2017, in respect of your Periyathirukonam & Alanthuraiyarkattalai Limestone Mine over an area of 44.705 Ha in Periyathirukonam & Alanthuraiyarkattalai Villages, Ariyalur Taluk & District, Tamil Nadu.

Sir,

The following provisions of the MCDR, 2017 were found violated in your above mine during the inspection on 18/07/2022 by undersigned in presence of the mine official Shri M. R. Raja Ranjith Singh, DGM (Mines) & Shri Johnson D., Sr. Mgr. (Mines):

Rule No.	Nature of Violation
11(1)	Mining operations have not been carried out as per the approved Modification to the Review of Mining Plan approved vide Letter No. TN/ALR/LST/MMP/2086.MDS dated 07.02.2022 to the extent as mentioned below:
	There was a proposal to backfill a total area of 2.44 Ha during the year 2021-22. However, only an area of 0.94 Ha was backfilled during the said period.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development (Amendment) Rules, 2021.
- 03. The mining operation can be suspended under Rule 11(2), if the compliance of Rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
