The following provisions of the MCDR, 2017 were found violated in your above mine during the inspection on 20/07/2022 by undersigned in presence of the mine official Shri S. Duraimurugan, DGM (Mines) & Shri J. Ravi, AGM (Geology):

11(1)	Mining operations have not been carried out as per the approved Review of Mining Plan approved vide Letter No. TN/ALR/LST/ROMP/1536.MDS dated 03.12.2018 to the extent as mentioned below:
	<ul> <li>a) There was a proposal to maintain an Ore to OB ratio of 1:0.46 during the year 2021-22. However, the same was maintained at 1:1.27.</li> <li>b) There was a proposal to excavate 1,77,840 tonnes of ROM during the year 2021-22. However, only 67,072 tonnes of ROM was excavated during the said period.</li> </ul>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development (Amendment) Rules, 2021.

03. The mining operation can be suspended under Rule 11(2), if the compliance of Rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
