The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned along with Shri. H M Shiva Kumar-Assistant Mining Engineer in presence of Shri. Pampapathi Garke - Manager Mines, Shri. Shashidhara L -Mining Engineer & Sri Kummara Anil Kumar - Geologist on 21.06.2021

Rule	Nature of violations observed
11(1)	Modified RMP along with PMCP was approved vide letter no.279/68/89/BNG dated 22.09.2020 for a period of 2020-21 to 2024-2025. The deviation observed in mining operation vis-a-vis approved document are given below
	It was proposed to extract 69500 Tons of iron ore and remove 5148 Tons of Overburden in the year 2020-21. During the inspection it was observed that only 36000 Tons of ore were extracted and 2668 Tons of overburden were handled.
47	It was observed that 13 core bore holes, 26 DTH and 18 trial pits were carried out in the mine against the proposal of 7 core bore holes and 17 DTH drilling as submitted in Form I. Revised Form I may be submitted to this office.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
- 03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
