Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above said mine during inspection on 21.08.2018 by the undersigned accompanied by S/Shri R.N. Kar, Sr.Manager (Geology), Satyendra Kumar Singh, Mine Manager of your mine.

26 (2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof.	A yearly report for the year 2017-18 as per the format specified by the Indian Bureau of Mines, setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan has not been submitted till date to this office.
67	The holder of a mineral concession shall furnish such information regarding his reconnaissance or prospecting operations or mining operations or any matter connected therewith as the authorised officer may require by an order in writing and the information shall be furnished within such time as may be specified in the such order.	Yearly report on self-appraisal note of approved mining plan for the year 2017-18 has not been submitted till date to this office.

02. It is brought to your notice that these violations constitute an offence punishable under Rule 62 of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within **45 (forty-five) days** from the date of issue of this letter.
