The following provisions of the Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection made on 19.06.2015 by the undersigned in presence of Shri A.K.Das, Mine Manager

Rule No.	Nature of violation observed in detail
13(1):	The mining operations are carried out in violation of following provisions of approved Mining Plan (approved on 18-01-2014): - (i) In Para 5.0 during the year 2014-15 mining was proposed from top to bottom by formation of benches up to 6m height but bench height were observed more than 10m. (ii) In Para 12.0 during the year 2014-15 50 saplings were proposed to plant; but no such plantation has been carried out.
45(5) (a)	Monthly returns for the months of April 2014 to Oct 2014, Jan 2015 to June 2015 have not been submitted to this office.
45(5) (b)	Annual returns for the year 2012-13 & 2014-15 have not been submitted to this office.
46	Notice of appointment of mine manager has not been submitted to this office.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.
03. The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 1988 is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office on letter pad signed by the owner within 45 (forty-five) days from the date of issue of this letter.
