Rule 11(1)	The mining operations are carried out in violation of following provisions of approved Scheme
	of mining (Approved on 06.04.2015): -
	1) In chapter 2.0 Mining: development and production was proposed in Nagri pit during
	the year 2015-16 & 2016-17 but no development activity was observed during the
	inspection in Nagri pit.
Rule 26 (2)	A yearly report to be submitted before 1 st July of every year setting forth the extent of protective
	and rehabilitation works carried out as envisaged in the approved mine closure plan has not been
	submitted to this office for the year 2016-17.
Rule 31(4)	Plans & sections required to be kept under rule 32 have not been maintained up to date within three
	months.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operation can be suspended under rule 11(2) of MCDR, 2017 if compliance of rule 11(1) of MCDR 2017 is not found satisfactory.
- O4. You are advised to rectify the above violations immediately and intimate the position to this office on letter pad signed by the owner within 45 (forty-five) days from the date of issue of this letter.
