Rule No. Nature of violation observed in detail The mining operations are carried out in violation of following provisions of approved Mining Plan (approved on 13(1): 07-03-2014): -As per proposal made on page no. 64 suitable species are to be planted along the road side similarly, constructions of retaining walls & check dams have also been proposed on page no. 73 of PMCP. But above proposals have not been implemented along the new constructed haul road from 804mRL to 630mRL and sides where loose debris is found in voluminous quantity. 27(4) Plans and sections has not been maintained; as per rule plans and sections shall be maintained up to date within three months in case of category'A' mines. 45(5) (a)

Monthly returns for the months of November 2015 to January 2016 have not been submitted to this office. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of 02.
