Baga Bhalag Limestone Mine in Solan District of Himachal Pradesh state.

महोदय,

The following provisions of the Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection made on 16.03.2016 by the undersigned in presence of Shri S.K. Sinha, Dy. General Manager(Mines)

Rule No.	Nature of violation observed in detail
13(1):	(A) The mining operations are carried out in violation of following provisions of approved Scheme of Mining (approved on 01-07-2014): - (i) In Para 5.0 In Bhalag Block (Crusher side) mine development and production was proposed in the year 2015-16 Between 1250mRL to +1340mRL by formation of 10 benches & 10m height of each. But only 03 benches were observed. It means proportionate development and production have not been carried out in Bhalag Block (Crusher side). (B) The production achieved were significantly higher during the period 2009-10 to 2013-14 than the proposed production given in the approved mining plan.
27(4)	Plans and sections have not been maintained as per rule plans and sections shall be maintained up to date within three months in case of category 'A' mines.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.
03. The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 1988 is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office on letter pad signed by the owner within 45 (forty-five) days from the date of issue of this letter.
