विषय : Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of your Pamta Limestone Mine in Sirmour District of Himachal Pradesh state.  
महोदय,

The following provisions of the Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection made on 07.09.2015 by the undersigned in presence of Shri Ajay Purkastha, Mine Manager

Rule No.	Nature of violation observed in detail
13(1):	The mining operations are carried out in violation of following provisions of approved Scheme of Mining (approved on 13-04-2011): - (i) In Para 5.0 it was proposed that mining shall be carried out by formation of benches 6m in height but mining development work in Western and Eastern Block were not going in accordance with approved scheme of mining. (ii) No effective preventative measures have been taken to prevent roll down the waste material into natural drainage in western & eastern block. (iii) Scheme of Mining is approved for category B (Manual Mining) whereas deployment of Hydraulic Excavator was observed.
45(5) (a)	Monthly returns for months January 2015 to August 2015 have not been submitted to this office.
45(5) (b)	Annual returns for the year 2014-15 has not been submitted to this office.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.
03. The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 1988 is not found satisfactory.
04. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.
05. Please note that no further notice will be given to you in this regard.
