**विषय/Subject: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your UTI Underground gold mine Mine, (ML 2126) over an area of 47.96 ha, located in Uti Village, Devadurga Taluk, Raichur district, Karnataka state.**

महोदय/Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection carried out by the undersigned and Shri Rohita Sethi, Assistant Mining Engineer in presence of Sri. Sh Apsarmiya, Mines Manager on 30.01.2020.

Rules	Nature of Violations observed
11 (1)	<p>Scheme of Mining Plan was approved vide this office letter no. 279/493/96/BNG dated 16/06/2016, for a period of 2016-17 to 2020-21. The deviation observed in mining operation vis-à-vis approved document are given below.</p> <p>i) It was observed that no exploration work has been carried out in Lode No 3 (Below 4<sup>th</sup> L) in the year 2018-19 against the proposal of 80m in Lode No.3 (Below 4<sup>th</sup> L).</p> <p>ii) It was observed that no work was carried out during the year 2018-19 in Lode no 4 against the proposal on Lode 3<sup>rd</sup>L(D/S), 5<sup>th</sup> L(D/N), 6<sup>th</sup> L(D/S), 3<sup>rd</sup> /6<sup>th</sup> L(R/W) and off Lode 6<sup>th</sup> LD/N of service shaft, 6<sup>th</sup> L Ore Bin development, 5<sup>th</sup> LOreBin development.</p> <p>iii) No BR was handled during the year 2018-19 against the proposal of 7866 tonnes, due to which the Ore to OB ratio has not been achieved as proposed.</p>

	<p>iv) Against the ROM proposal of 16530T from Development &amp; 43470T from Stope, only 15360 tonnes of ROM achieved from Stope Block.</p> <p>v) During inspection it was observed that the waste material/BR was dumped outside the ML area.</p>
<b>26(2)</b>	Yearly report on PMCP setting forth the extent of protective and rehabilitative works carried out as per the approved Progressive Mine Closure Plan has not been submitted till date.
<b>45</b>	The land use pattern submitted in annual return under different heads is not matching with the total lease area.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.

03. You are advised to rectify/explain the above violations immediately and intimate the position to this office **within 45 (Forty Five) days** from the date of issue of this letter.
