	It was observed that Nil Tons of Shale was produced against the proposal of 973336 Tons, thereby resulting in 100% deviation.

Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
