The proposal of five years period of the approved Mining Plan has been expired on 20-01-2014. As per the rule the scheme of mining for next five years should be submitted at least 120 days before expiry of
the five year proposals. But the scheme of mining has not been submitted to this office so far to the Regional Controller of Mines for his approval.
Monthly returns have not been submitted from March 2015 to January 2016.
Annual return for the year 2014-15 has not been submitted to this office.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.
- 03. The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 1988 is not found satisfactory.
- 04. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.
