Nature of violation observed in detail

The mining operations are carried out in violation of following provisions of approved Scheme of Mining (Approved on 11-12-2013):
1) In Para 5.0 it was proposed to develop mine by forming benches each of 6m in height with width more than the height whereas at some places the height of the benches more than 10m with vertical

and irregular faces have been developed.
In Para 4.0 of PMCP during the year (2014-15) 75m retaining wall was proposed around the dump but no such retaining wall was made.

- 02. However the reply furnished by you in compliance of Rule13 (1) & 45(5) (a) was duly considered so compliance of Rule 45(5) (a) has been considered but the reply for the rule 13(1) was not found satisfactory.
- 03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.
- O4. The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 1988 is not found satisfactory.
- O5. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.
