13(1):	-	Mining operations were carried out in violation of following provisions of approved Modified Scheme of Mining (approved on 24/06/2015).
	(i)	In Chapter 2 of Part A it was proposed to develop benches of 6m in height whereas benches of more than 10m in height with vertical and irregular faces have been developed. Sequence of mine development is not as per proposal given in approved scheme of mining.
	(ii)	No effective preventative measures have been taken to prevent roll down the waste material into natural drainage.

- In this connection, it is brought to your notice that the above violations constitute an offence punishable 02. under Rule 58 of MCDR, 1988.
- The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of 03. MCDR 1988 is not found satisfactory.
