विषय : Violation of provisions of Mineral Conservation & Development Rules, 1988
in respect of your Banaur Limestone Mine in Sirmour district of Himachal Pradesh.

महोदय,

The following provisions of the Mineral Conservation and Development Rules, 1988 was found violated in your above mine during the inspection by Shri A.K. Vig, Assistant Mining Geologist on 14.04.2014.

Rule No.	Nature of violation observed in detail
13(1):	Mining operations were carried out in violation of following provisions of approved Modified Mining Plan (Modified mining plan approved on 21.02.2014). (i) In Para 5.A.3 it was proposed to develop mine from 1390mRL in block A and from 1366 mRL in block B by forming benches each of 6m in height with width more than the height but mining is being carried out with face height of 6 to 9m. (ii) It was proposed that 300 saplings will be planted during the year but the same has not been planted. (iii) It was observed that waste material was lying near the working pits, it should be dumped at proposed dumping yard & check dams to be repaired to check the flow of the waste material.
45(1)(a):	Monthly return of the mine has not been submitted to this office for the month of December 2013.

02. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.
03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
