Sub: Violation of provisions of MCDR, 2017 in respect of your Lawa Gold Mine over an area of 54.55 hect ,in Saraikela -Kharsawan district, Jharkhand state.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017(MCDR, 2017) were found violated in the above mine during inspection on 13/03/2021 by the undersigned in presence of Shri A.K.Gautam, lessee's Representative, Shri Saryu Pandey, Mines Manager & Shri Jhuman Ghosh, Geologist and was communicated to you vide this office Registered post letter even no. dated 26/03/2021 giving you a period of 45(Forty five) days' time for rectification of the same.

Rule No.	Nature of Violation in detail
Rule 33:-	A digital copy alongwith a print copy of Surface Geological Plans and sections maintained under Rule 32 have not been received on or before the 30 th June 2020 by the authorized officer of Indian Bureau of Mines, Ranchi.
Rule 45(7):-	The following incomplete/wrong information have been furnished in the Annual Return in Form H-5 submitted online, for the year 2019-20:-

- (i) In Part V, Section 7 for Gold in item 7(ii) the Quantity & Average Grade of Concentrates have not been given.
- (ii) In Part VI, item 2, the ex-mine price given is not correct. Instead of Cost of production at Part VII of the Annual Return, Deductions claimed at item 6 have been given.
- (iii) In Part VI, item 3, (a) No Quantity, Value & Metal Grade of Gold concentrate obtained have been given.
- (iv) In Part VI, item 6, Deduction of Rs600/te for drilling & blasting given is not correct. It should be added in the mining cost at Part VII.

Rule 46:-Notice of appointment of Sri Jhuma Ghosh, as Geologist and Sri Saryu Pandey as Mines Manager, w.e.f. 15/07/2018 have not been received in Form-H by this office within fifteen days of their appointment.

Rule 47:Total 423m in Balukhad & Tamapahar Section have been drilled during 2019-20, but the Notice of drilling Boreholes in Form-I, have not been received, within fifteen days after commencement of drilling operations.

Rule 48: Records of Boreholes have not been maintained in Form-J at the mine.

Rule 55(1)(3)(iv) : For the purpose of carrying out mining operations in accordance with these rules, every holder of a mining lease shall employ, in case of Category 'B' mines, a Part-time mining engineer and a Part-time Geologist, having Qualification as per Rule 55(6).

In your case, a Degree Holder, Part-time Mining Engineer has not been employed.

02. It has been found that even after lapse of 45 days from the issue of violation letter dated 26/03/2021, you have not responded till date.

Therefore, the violations of Rule 33, 45(7), 46, 47, 48, 55(1)(3)(iv) still continues.

03. In this connection it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017.

04. You are, therefore, directed to show-cause within a period of 30(Thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence for non compliance of Rule 33,45(7),46,47,48,55(1)(3)(iv) of MCDR, 2017.

05. Please note that no further notice will be given to you in this regard.


