**Sub: Violation of provisions Rule 35(4) of Mineral Conservation and Development Rule, 2017 in respect of "Betla Graphite Mine" of M/s. Parijat Mining Industries (India) Pvt. Ltd, over an area of 7.216 Hectares in Betla Village, Latehar District, Jharkhand State – reg.**

Sir,

On the examination of this office records, it is observed that the following provisions of Mineral Conservation & Development Rules, 2017 are violated in respect of your above referred mine.

Rule No.	Nature of Violations observed
35(4)	As per this rule your above subject mentioned mine has not achieved at least three star rating within a period of four years with effect from the date of notification of MCDR 2017 i.e, 27/02/2017 or four years from the date of commencement of mining operations.

2. The Rule 35(4) of MCDR is reproduced below:-

*"The Regional Controller or the authorised officer of the Indian Bureau of Mines may suspend the mining operations in those mines where at least three star rating has not been achieved within a period of four years with effect from the 27th February, 2017 or four years from the date of commencement of mining operations, as the case may be, after giving a show cause notice of forty-five days, to qualify for star rating";*

3. You are, therefore, directed to show cause within a period of **45(Forty Five) days** from the date of issue of this letter, as to why your mining operation are not be suspended for the above offences.

4. Please note that no further notice will be given to you in this regard.
