Sub: Violation of provisions of Mineral Conservation and Development Rule, 2017 in respect of "Balaji" Iron Mine mining code 30BHR27031 over an area of 19.331 Hects. in Singhbhum (West) District of Jharkhand State – reg.

Sir,

On the examination of this office records, it is observed that the following provisions of Mineral Conservation & Development Rules, 2017 are violated in respect of your above referred mine.

Rule No.	Nature of Violations observed
45(5)(b)	The monthly return which shall be submitted before the tenth day of every month in respect of the preceding month in electronic form along with a signed print copy of the same if it is not digitally signed, in the respective form. <i>(As per this office record the Monthly Returns for the month of March-2021 has not been submitted so far in electronic form)</i>

2. In this connection, it is brought to your notice that, the violation of said rules constitutes an offence punishable under Rule 62 of MCDR, 2017 and if the above rules are not complied; The Regional Controller of Mines may advise to State Government to take following action under rule 45(7)(a):

- order suspension of all mining operations in the mine and to revoke the order of suspension only after ensuring proper compliance;
- take action to initiate prosecution under these rules;
- recommend termination of the mining lease, in case such suppression or misrepresentation of information indicates abetment or connivance of illegal mining;

3. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45(forty five) days from the date of issue of this letter.
