Sub:- Violation of provisions of MCDR, 2017 in respect of your “Tamdaga Graphite Mines (34.535 Ha.) in Palamu District of Jharkhand State.

Sir,

Based on the office records the following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine.

| Rule No. | Nature of violations observed in details. |
|---------------------|---|
| Rule- 11(4): | The holder of a Mining Lease has not submitted the Mining Plan to the competent authority for review at least one hundred and eighty days before the expiry of five years period for which it was approved on the last occasion, for mining operations for a period of five subsequent years. |
| Rule 23: | The holder of a mining lease shall submit to the competent authority a progressive mine closure plan as a component of the mining plan, at the time of submission, modification and review of the mining plan. |
| Rule 27 (2): | A financial assurance shall be furnished by the holder of the mining lease, for due and proper implementation of the progressive mine closure plan contained in the mining plan or the final mine closure plan. |
| Rule 45(1): | Your Mines has not been registered with Indian Bureau of Mines till date. |
| Rule 55: | Employment of geologists and mining engineers has not been done so far as the re-opening of the mines is mentioned as 07/01/2020. |

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule-62 of MCDR-2017.

03. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
