Sub: Violation of provision of MCDR, 2017 in respect of Palkur Limestone Mine over an area of 1.902 ha in Palkur Village, Banganapalli Mandal, Kurnool district, Andhra Pradesh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in the above mine on during the inspection on 14.06.2017 by P.Guruvaiah, Assistant Mining Geologist of this office accompanied by Sri N. Vamshi Krishna, Lessee, s Son.

Rule No.	Nature of Violation
11(4)	“The holder of a mining lease shall submit the mining plan to the competent authority for review at least one hundred and eighty days before the expiry of five years period for which it was approved on the last occasion, for mining operations for a period of five subsequent years.” The proposals made in the earlier document approved on 7.7.2009 was expired on 31.03.2014.
28(1)	During the Inspection, it was found that the work in the mine is discontinued for a period exceeding ninety days, but notice thereof in Form-E as required under this Rule has not been submitted to the Regional Controller of Mines, Indian Bureau of Mines, Hyderabad so far.
55(3)(iv)	Every holder of a mining lease shall employ, in case of – category ‘B’ mines, a part time mining engineer and a part time geologist. However you have not employed Mining Engineer and part time geologist.
45(5)(b)(i)	Monthly Returns in Form F-1 since April, 2017 to May, 2017 have not been submitted to the Regional Controller of Mines, IBM, Hyderabad till date as required under this rule. The Monthly Returns should be submitted before 10th of every month in respect of preceding month.
45(5)(C) (i)	Annual Returns in Form G-1, for the year 2014-15 has not been submitted to the Regional Controller of Mines, IBM, Hyderabad till date as required under this rule. The Annual Returns should be submitted before 1st July of every year in respect of preceding year..

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017.

03 You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
